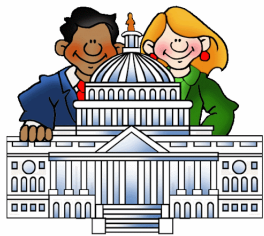

224 guests and **21** volunteers joined us for our annual Snowflake Ball for dinner and dancing.

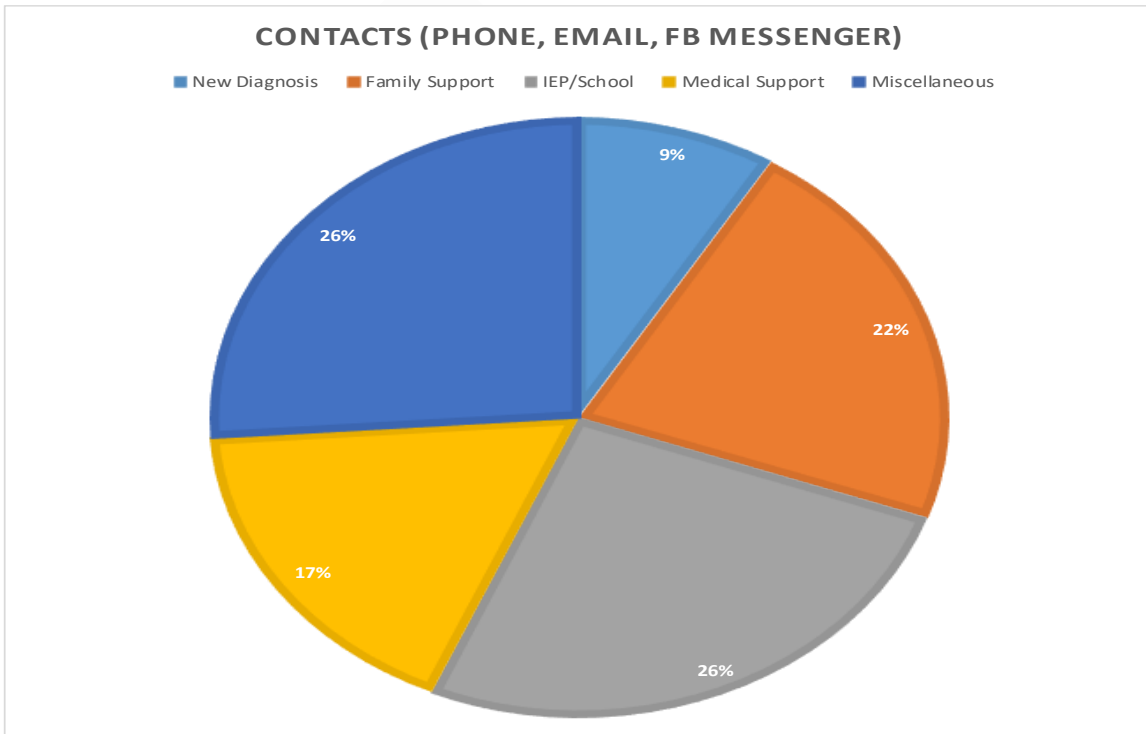

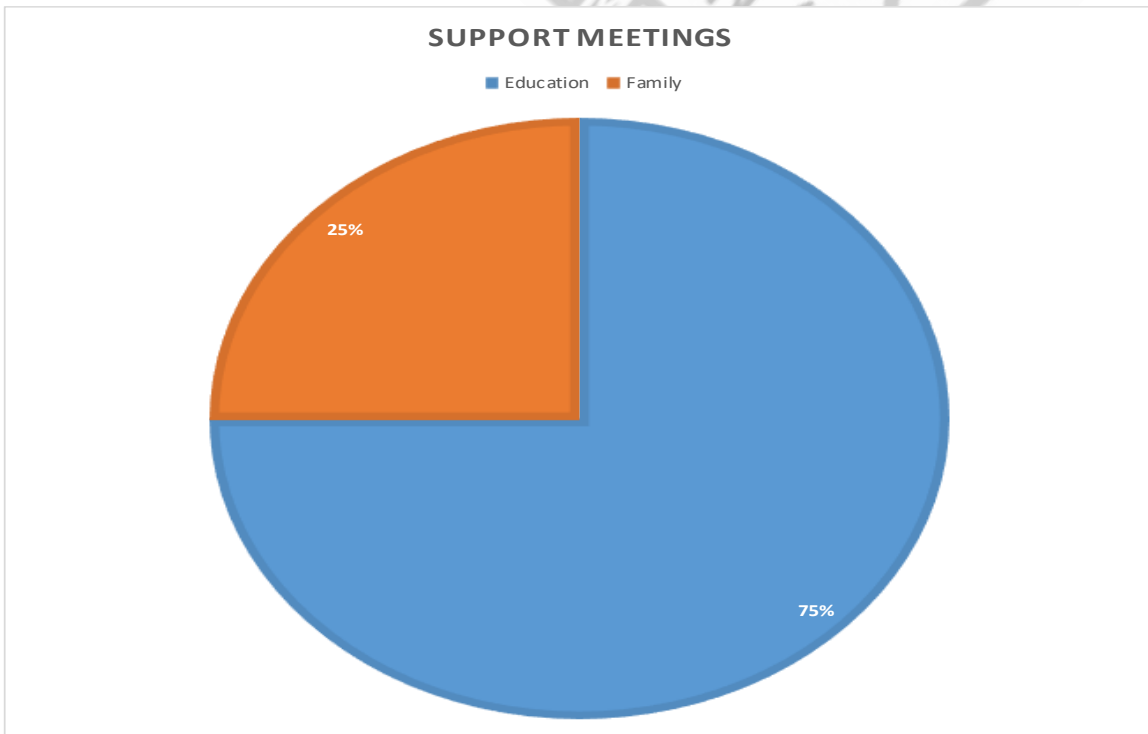
145 individuals with PWS living in Wisconsin received a birthday card and several seasonal cards at no cost to them.
